

FINANCES

Sachtleben Minerals remains a profitable company group independent of bank financing and thus crisis-proof.

- We aim to achieve a double-digit EBITDA margin, which is customary in the industry, in order to increase the value and sustainably strengthen the financial power of the group of companies. This goal is also reflected in our long-term planning.
- Dependency on banks and connection to a corporate group is to be avoided.
- A stable provision of funds by shareholders with long-term investment intentions must be ensured.
- The average annual growth in turnover should be above the inflation rate.
 For this purpose, the markets and their potential are continuously scanned.
- Investments are measured by their contribution to the achievement of our objectives.

We expand our significant position in markets for innovative fluorspar and barite products and use Cu/Ag as an important portfolio addition.

We continuously master and improve our processes and are always able to resolve new challenges.


- Our staff is developed in the long-term by early planning and training.

ENVIRONMENT& CLIMATE PROTECTION

We use our natural mineral resources responsibly and emphasise the importance of climate protection by our climate strategy included in our quality management manual. The responsible use of energy and the protection of environmental property such as human beings, animals, plants, water, climate, air, soil and landscape are the basis for our actions.

- By monitoring the raw material input ratio (turnover-related), an efficient use of raw materials is ensured.
- The long-term utilisation of tailings and waste rock is secured by a controlled tailings and waste rock management both on surface and underground.
- Our objective is the maximum utilisation of our deposit with minimum dilution.
- We maintain a high level mineral recovery with an increasing share of premium quality products.
- Our objective is to optimise our use of energy and thus to continuously improve energy efficiency. For this we strive to find and establish long-term economic solutions for reducing energy consumption and to increase the use of self-generated renewable energy.
- Legal and regulatory requirements are implemented.
- Risks from hazardous waste are reduced by monitoring and restoration.
